V. QUALIFYING FORMAT:

The state swim meet will have three (girls)/ two (boys) classifications for team scoring.

VI. NOTES:

- A. State Championships are a top 20 finals.
- B. Only entries certified by CASO officials and swum in Colorado State High School meets will

be accepted as state qualifying times.

- C. Swimmers who have restricted eligibility due to transferring cannot swim Exhibition heats while restricted.
- D. All swimmers and divers must compete in a minimum of six (6) high school meets, excluding league or conference championship, in order to be eligible to compete at the state championships. A dual, double-dual, triple-dual, invitational (championships and non-championship) or multi-team meet shall only be counted as one meet towards your 6-meet minimum and your 11-meet maximum for CHSAA state qualification purposes. League relay meets, B League, and C league meets each count as one regular season meet. Athletic directors may apply for a waiver through the CHSAA Swimming/Diving Commissioner, based on regular season scheduling issues prior to the state meet entry deadline.
- E. All meets should be uploaded into MaxPreps 48-hours after completion. All meets must be uploaded into MaxPreps prior to the state entry deadline. In order for transparency, this requirement is both for state qualification standards as well as to document that everyone has met their minimum and maximum stands for state qualification. Meets not uploaded to MaxPreps prior to the state entry deadline cannot count towards qualification or minimum entry qualification requirements.

- In order to qualify under the 6-dive standard, the diver must meet the qualifying standard two times during the season.
- ** In order to qualify under the 11-dive standard, the diver must meet the qualifying standard only once during the season.
- Menotes change in qualification standards.

Note: The diving DD (Degree of Difficulty) refers only to the OPTIONAL dives. (The sum of the 5 optional dives in a 6-dive meet or the sum of the 6 optional dives in an 11-dive meet.)

Note: At state, all divers will perform five (5) dives. The diving cut (reducing the field) will occur after the preliminary rounds, to twenty-four (24) competitors.

Note: All divers competing in the state meet must have at least the required optional DD as listed in the chart above for their classification on their diving score sheet at the state meet.

Note: If a school has more than four (4) swimmers or divers who qualify for the finals, the additional athletes who have qualified but who do not have one of the top 4 times on their team will not be listed as one of the alternates in the event and will not be able to move into the finals heat(s) even if a competitor drops out. Only the top four swims from the preliminary competition from each team are eligible to advance to the finals competition. No substitutes will be allowed.

VII. INFORMATIONAL ITEMS:

All swimmers and divers must compete in a minimum of six (6) high school meets, excluding league or conference championship, in order to be eligible to compete at the state championships. (refer to "notes" above).

State Entries will be submitted online and verified by MaxPreps, the official State Qualifying Database. All entries are final after the deadline.

3-2-2 Schools may enter their relay teams with eight individual names for championship meets.

State Association Adoption of NF Playing Rules:

- 3-1-1 In CHSAA State Championships meets, each team shall be permitted unlimited entries in individual events and one entry in the relay events. Individual and relay entries must meet the qualification standard with only four individuals from each team being eligible to advance past the preliminary round. The individual entry rule shall be followed. *For regular season championships format meets (prelims/finals), Rule 3-1-1 shall be adhered to unless by mutual consent, or unless league bylaws specify otherwise.
- 5-1-1 Events may only be modified for non-varsity and invitational competition.
 - A. Modification of J.V. Events Dual Meets Only
 - 1. 200 IM modified to 100 IM
 - 2. 100 Butterfly, modified to 50 Fly
 - 3. 100 Backstroke, modified to 50 Back
 - 4. 100 Breaststroke, modified to 50 Breast
 - 5. 6 Round Dives, modified to 3 Dives
 - Mutual consent by both coaches prior to the meet.

- Notification to official if more than four J.V. events.
- B. Modification—Invitationals may be modified to add or drop events and order of events.
